MESSAGE FROM THE ATTORNEY GENERAL

Dear Law Enforcement Official:

At the Department of Justice, we exist to assist you in our common mission to enhance public safety. I am a firm believer that local officials are in the best position to understand the needs of their communities. If the state is to assist, then state officials need to understand and appreciate the concerns of individual communities. That's why I am holding Law Enforcement Roundtables in all of Wisconsin's 72 counties. As of the date of this publication, I will have held roundtables in 36 counties.

I co-host each roundtable with one or more area legislators. Typically, the roundtables are held in the county seat and run for one and one half hours. Invitations are sent to law enforcement and community leaders, as well as judges and other officials.

The roundtables are an open forum. All topics relating to public safety are on the table for discussion. In visiting these counties and listening to what community leaders have to say, two things have been affirmed. First, each county shares significant concerns with other counties across the state. Second, each county has their own unique issues.

While I come to these roundtables to listen, listening is not the end of the process. I take back to the Department of Justice the concerns I hear at each roundtable. Issues raised are given to my staff for follow-up. Some of the follow-up can be done quickly, and participants will get phone calls from my staff trying to give assistance. Others, such as legislative ideas, are internally vetted and we follow up with lawmakers. As the legislative session begins again in January 2009, I hope that some of the concerns that have been raised will get considered and I can help your voice be heard in Madison.

I have enjoyed traveling around the state meeting many of you and I look forward to meeting those of you I have not met as I continue my roundtables around the state. At every roundtable, I ask that the meeting not be the end of the conversation, but the beginning. The only way that we can do our jobs better is if we hear from you. On the inside cover of each Law Enforcement Bulletin is a directory of Department of Justice personnel that may be able to help you address a specific concern or follow up on a suggestion as to how we in state government can help you achieve our mutual mission of a safer Wisconsin. Please keep in contact with us as we move forward.

State v. Timothy Neitzel Decided by the Court of Appeals- August 21,

Introduction:

This case involved whether or not a defendant has an expectation of privacy in a gas station rest room. The court ruled that under the circumstances the defendant did not have an expectation of privacy in the rest room that society would deem as reasonable.

Facts:

The police responded to a gas station in response to a dispatch about a possible intoxicated driver who had pulled into the parking lot. Upon arriving at the station the police observed a lone vehicle parked in the parking lot which matched the description and had the license plate number of the vehicle complained about. The police made contact with the station clerk who advised that a man had come in, who appeared disoriented, and who stated that he really shouldn't be driving. The man had gone to the restroom and had been there for at least 20 minutes. The clerk advised that there were two keys for the washroom, the one used by the defendant and the one the clerk kept and now gave the police.

The police went to the restroom and after waiting for about five minutes began knocking on the rest room door. When no one answered the knock the police used the key and entered the restroom. The police found the defendant asleep on the toilet. After being aroused the police dealt with the defendant and eventually arrested him for OWI- fourth offense.

The Defendant's Argument:

The defendant argued that the entry into the restroom was unlawful since the police had no 4th amendment justification for the entry. Consequently all the evidence obtained after the unlawful entry into the restroom should be suppressed as "fruit of the poisonous tree".

The State's Argument:

The state argued that the entry was justified under the exigent circumstance doctrine. The state also argued that the defendant did not have a reasonable expectation of privacy in the gas station restroom.

The Court's Holding:

The court of appeals agreed with the state and held that even though the defendant might have had a subjective expectation of privacy in the rest room it was not an expectation under the circumstances that society would deem reasonable. The court reprised the case of State v. Orta 2003 WI App 93, 264 Wis.2d 765 in evaluating whether an expectation of privacy is a reasonable one. Orta set forth six factors in making the determination. 1) whether the person has a property interest in the premises, 2) whether the person was legitimately on the premises, 3) whether the person has complete dominion and control and the right to exclude others, 4) whether the person took precautions customarily taken by those seeking privacy, 5) whether the person put the property to some private use and 6) whether the claim of privacy is consistent with historical notions of privacy.

Applying the six prong test the court concluded that the defendant did not have an expectation of privacy in the restroom when the police made their non-consensual entry. The court reached this conclusion primarily because the defendant was in the restroom for over twenty five minutes, was sleeping on the toilet and did not respond to knocking. The court reasoned that under the circumstances the defendant forfeited any expectation of privacy he might have originally had in the restroom. Since the court held that the defendant did not have a reasonable expectation of privacy the police did not need a fourth amendment justification to enter the restroom.

INTERNET CRIMES AGAINST CHILDREN

Attorney General Van Hollen has placed a priority on law enforcement's proactive response to the growing problem of internet crimes against children. To that end, he has directed a 67% increase in the number of special agents assigned to the Internet Crimes Against Children Task Force within the Division of Criminal Investigation. The Attorney General's 2009-11 budget request for the Department of Justice includes a request for additional special agents and criminal analysts to protect our children from sex predators who utilize the Internet to prey on children.

In addition to expanding investigative capacity internally, Attorney General Van Hollen and the Department of Justice have continued to add additional local affiliates to the Wisconsin ICAC Task Force. The number of local law enforcement partners to the Department of Justice's ICAC Task Force has more than doubled to 64 in the past year.

FBI OFFICERS KILLED

These statistics represent preliminary information received by the FBI, January through October 2008: Thirty-four law enforcement officers have been killed due to criminal actions. During the same time period in 2007, 51 officers were slain. Nineteen deaths occurred in the south, seven in the west, six in the midwest, and two in the northeast. Circumstances involving the 34 slain officers are as follows: seven were performing traffic pursuits/stops, six were investigating suspicious persons or circumstances, four were ambushed, four were involved in tactical situations, three were slain while attempting other arrests, three were answering disturbance calls (one being domestic disturbance call), three were responding to burglary calls, two officers were involved in drug-related situations, one was responding to robbery call, and one was handling prisoner(s). Firearms were used in 30 of the 34 killings (19 handguns, five shotguns, four rifles, and two firearm types were not reported) and vehicles in four. Twenty officers were wearing protective vests. There have been 32 separate incidents in which these 34 officers have been slain. Thirty of the 32 incidents have been cleared by arrest or exceptional means. Forty-three law enforcement officers have been accidentally killed. During the same time period in 2007, 72 officers were accidentally killed. Nineteen deaths occurred in the south, nine in the west, seven in the northeast, five in the midwest, and three in U.S. territories (two in Puerto Rico and one in the U.S. Virgin Islands). Twenty-eight officers were killed in automobile accidents, six were struck by vehicles, three were fatally injured in motorcycle accidents, two were accidentally shot, one was killed in aircraft accident, one was killed by electrocution, one officer was a drowning victim, and one officer was fatally injured in train collision.

Incident Summaries

Chicago Police Department, Illinois, Veteran Detective, aged 45 with over 18 years law enforcement experience, was shot. On 08/21/2008, arrest team comprised of FBI agents and federal task force officers, including detective, assembled to locate subject know as bank robber. Arrest team converged at subject's girlfriend's apartment. During arrest inside apartment, subject shot Victim Detective in head, immediately disabling him in back bedroom. Subject, using .44 caliber revolver and .45 caliber semiautomatic handgun, began firing both firearms from back bedroom and shot into living room where other agents were located and where no cover was

available. Agents returned fire, striking but not disabling subject. Even after being hit, subject continued to fire at agents from his position of cover and agents were forced to retreat to their nearest position of cover out of apartment and into building hallway. After more than two hours of negotiations, SWAT team entered apartment, retrieved victim Detective, and took subject into custody without further incident. Victim Detective was in coma and never regained consciousness. On 11/04/2008. victim Detective succumbed to his injuries at 53 years of age. After conviction, subject was sentenced to life in prison for holding victim Detective hostage during nearly two-hour standoff, 30 years on various other counts including bank robberies and assaults on victim Detective and other agents, and 132 years for several weapons violations. In addition, subject was ordered to pay restitution to cover victim Detective's medical bills, cash taken during bank robberies and not recovered, and other expenses.

University City Police Department, Missouri, Veteran Sergeant, aged 50 with over 25 years law enforcement experience, was fatally shot on 10/31/2008. At approximately 10:21 p.m., Sergeant was sitting in patrol vehicle when subject, armed with .38 caliber Smith & Wesson revolver, approached patrol vehicle and shot multiple times. Sergeant received injuries to side head, front upper torso, and arms/hands. Fatal gunshot wound received to front upper torso circumvented victim Sergeant's body armor by entering through armhole/shoulder area of vest. Subject fled scene of incident in personal vehicle and was pursued by officers. Subject escaped pursuit, but was captured in Kansas City, Missouri, area by Missouri State Highway Patrol officers on 11/04/2008. Subject was arrested and charged with felon in possession of firearm. State homicide charges are anticipated.
