MESSAGE FROM THE ATTORNEY GENERAL

Dear Law Enforcement Official:

The TIME system is the critical information network relied on by law enforcement officers for timely, accurate, on-the-scene information. The TIME system network has been operational for over 35 years. During much of that time, Wisconsin motor vehicle operator licenses have included photographs. And for the past 10 years, law enforcement has had the ability to make a written request to DOT for drivers' license photographs. But as the technical capability to transmit images in real time over the TIME system has become a reality in recent years, the law—at least as it relates to drivers' license photos—has lagged behind.

As Attorney General, I've had the privilege of traveling the state and meeting with many of you to talk about what we can do at the state level to help you do your jobs better. One issue that's been repeatedly raised is the desirability of the TIME system to carry drivers' license photos. And it's an issue with good reason. Public safety and law enforcement can be considerably enhanced by enabling real-time access to DOT photos. Electronic access to DOT photos through the TIME system would improve officer safety, help quickly identify false identification or misidentification, and can contribute to the safe recovery of missing persons.

At DOJ, we have the capability of providing images over TIME, and with minor modifications to enable our computers to talk to DOT's computers so that we can receive DOT's images in real time, we can make electronically providing drivers' license photos to law enforcement a reality. But we need changes to our law. Fortunately, legislation was introduced by Representative Kitty Rhoades to allow DOJ to do just that. I had the privilege of testifying before the Assembly Transportation Committee in support of AB-639 in January, and on February 26, the Assembly passed the bill on a voice vote. That indicates broad bipartisan support for this legislation. I am cautiously optimistic that the Senate will act on this legislation and it will be signed into law by the Governor.

If this legislation is enacted, it won't be costless to the Department of Justice. But I will direct my office to take advantage of federal funding available to assist states in facilitating interstate driver photo sharing, and I have pledged to cover other costs with discretionary monies that the Department of Justice is awarded through its litigation activity. I am committed to using these limited funds to enhance DOJ operations and law enforcement projects that have a strong nexus to the agency – just like upgrading TIME to enable real-time access to DOT photos.

Electronic access to DOT photos makes DOJ better and I believe it makes local law enforcement and the communities they protect safer. I am hopeful this bill will become law.

State v. Scott M. Hambly Decided by the Wisconsin Supreme Court February 7, 2008

Issue:

This case involved the implications of when a subject in custody invokes his right to an attorney before he/she is actually read the Miranda warning. The case also deals with the circumstances surrounding a subject reinitiating a dialogue with the police after having already invoked their right to counsel.

Facts:

The defendant was approached by detectives in a parking lot who told him that they wished to speak to him about several drug transactions. The defendant declined to speak and shortly thereafter he was arrested. After being arrested and in custody, but before the police had a chance to read the defendant his Miranda warning the defendant clearly stated that he wanted to speak to an attorney. The police did not question him but very shortly after that the defendant told the police that he did not know why he was arrested and the police told him it was because he had sold cocaine to an informant. The defendant again told the police that he was not sure what was going on and that he wanted to speak to the detective to find out what his options were.

The detective then read the defendant his Miranda warnings, the defendant waived his rights and then admitted that he had sold cocaine.

The Defendant's Argument:

The defendant argued that his statements should have been suppressed since he had asserted his Miranda right to a lawyer, and therefore the police should have stopped talking to him and since his confession came so close to his assertion, he should not be perceived as reinitiating the conversation.

The State's Argument:

The state argued that the defendant can not assert his Miranda rights before being read the form unless he does so immediately before the form is to be read. Therefore since he asserted way before any questioning was likely to occur he really did not assert his right to a lawyer under the Miranda doctrine. Second the state argued that even if the defendant did assert his Miranda right to a lawyer he effectively reinitiated the contact with the police when he told them he did not understand what was going on and wanted to talk to the detective to find out what his options were.

The Wisconsin Supreme Court Holding:

The Wisconsin Court split equally (Justice Ziegler did not participate) on the issue as to whether a defendant can assert their Miranda rights in custody but appreciably before questioning was to take place. The Court agreed with the state that while very little time elapsed between the defendant's assertion of his Miranda right to counsel and his expressed wish to talk to the police, it was a lawful reinitiation since the police did not trick him or coerce him or compel him to change his mind. Consequently, the Wisconsin Supreme Court did not suppress the defendant's confession.

Note: Since 3 justices clearly held that a defendant can invoke his Miranda right to an attorney any time he/she is in custody and before being read the form, and the other 3 judges did not so rule because they did not have to in this case, the safest course is to presume that a defendant can invoke at anytime so long as they are in custody. **However,** as always the invocation has to be clear and unequivocal.

Also, while timing is one factor in determining whether a defendant is reinitiating an interrogation there can be a reinitiation quickly after the assertion so long as the police did not provoke it.

FBI OFFICERS KILLED

These statistics represent preliminary information received by the FBI, January 2008: Four law enforcement officers have been killed due to criminal actions. During the same time period in 2007, six officers were slain. Three deaths occurred in the south and one in the west. Circumstances involving the four slain officers are as follows: two were investigating suspicious persons or circumstances, one was performing traffic pursuit/stop, and one officer was slain while attempting other arrest. Firearms were used in two of the four killings (one handgun and one rifle) and vehicles in two. One officer was wearing protective vest. There have been four separate incidents in which these four officers have been slain. All four incidents have been cleared by arrest or exceptional means. Three law enforcement officers have been accidentally killed. During the same time period in 2007, two officers were accidentally killed. Two deaths occurred in the south and one in the Midwest. Two officers were stuck by vehicles and one was killed in automobile accident.

Incident Summaries

Miami Police Department, Florida, Veteran Detective, aged 30, with over six years law enforcement experience with agency was fatally shot At approximately 12:45 a.m., on 01/08/2008. individual was seated in vehicle with companion in rear alley located in North Miami Beach. Location is considered high crime area as well as known for a violent gang. Individual in vehicle was confronted by subject armed with AD-47 rifle as subject shot numerous rounds into individual's vehicle, striking him once in shoulder. Attempting to elude subject, individual exited vehicle and fled on foot with subject in pursuit. Wounded individual was picked up by citizen and transported to police department. While confrontation was occurring between subject and individual, detective inadvertently entered alleyway in unmarked police vehicle, driving into It appears that detective and subject gunfire. exchanged gunfire as detective drove through alleyway. Victim detective was fatally struck at least once in neck. Upon responding to call, North Miami Police Department officers witnessed subject fleeing scene and detained him. Individual and companion who were initially involved in attack with subject positively identified subject as gunman who had shot

at them. Canvas of neighborhood also revealed witness who identified subject fleeing from scene. On 01/09/2008, subject was arrested and charged with two counts of attempted first degree murder.

Bell County Sheriff's Department, Kentucky, Deputy, aged 31, with over four years law enforcement experience with agency was fatally struck by subject vehicle shortly after midnight on Subject vehicle, occupied by two 01/10/2008. juveniles, was being pursued by Kentucky State Police (KSP) troopers. Pursuit was predicated upon traffic violations and information occupants of subject vehicle were involved in gasoline larceny. According to KSP investigators and KSP pursuit vehicle video, subject vehicle accelerated and intentionally struck passenger side of victim deputy's parked patrol vehicle. Collision instantly killed victim deputy and his K-9 partner. Subjects have been arrested and each charged with one count of murder of police officer and first degree assault of service animal.

Dekalb County Police Department, Georgia, Two Officers were fatally shot on 01/16/2008 (one patrol officer, aged 26, with approximately two years law enforcement experience with agency and one patrol officer, aged 34, with over four years law enforcement experience with agency). approximately 12:50 a.m., patrol officers responded to disturbance call at apartment complex. After brief encounter with subjects in parking lot of apartment complex, both officers were shot at close range by subject using .40 caliber semiautomatic handgun. Only one victim officer was able to return fire. This officer was struck once below his ballistic vest, but was mortally wounded when the round traveled upward and severed his aorta. Second victim officer, who was standing next to first victim officer, has his baton in hand but was shot twice in head and was unable to return fire. One subject remained at scene of incident and was subsequently arrested by responding officers. This subject later informed investigators of subject's identification who was responsible for shooting victim officers. Massive manhunt ensued, including numerous local, state, and federal agencies, in attempt to locate three additional subjects. One of these three subjects turned himself in to authorities on 01/17/2008, but was later released after investigation showed he was not participant in shooting. On 01/18/2008, two other subjects were arrested by law enforcement officers with local agencies and U.S. Marshal's Service. Three subjects (one who remained at scene of incident and two who were arrested on 01/18/2008) remain in custody and are awaiting trial pertaining to murders of two victim officers.

Chesapeake Police Department (CPD), Virginia,

Veteran Detective, aged 34, with over seven years of law enforcement experience with agency was fatally shot on 01/17/2008 at approximately 8:30 p.m. CPD officers were attempting to serve narcotics related warrant on subject. Narcotics officers announced their presence and partially breeched door when two .380 caliber rounds were fired from inside address. One round passed through door, entered armhole area of victim detective's ballistic vest, and struck victim's chest. Wounded detective was transported by ambulance to hospital where he succumbed to his wound. Subject was apprehended and charged with first degree murder and use of firearm.

U.S. Border Patrol, Yuma, Arizona, Veteran Agent, aged 31, with approximately six years law enforcement experience with agency was fatally struck by vehicle on 01/19/2008. Border Patrol agents noticed two vehicles crossing from Mexico into United States and began to follow them. As drivers of suspect vehicles noticed agents following them, they turned around and began to drive in direction they had come from. As agent was deploying spike strips to stop fleeing vehicles, subject intentionally struck victim agent. Suspected driver of this vehicle was arrested in Mexico and is currently in custody. Driver of second suspect vehicle remains at large.

New Orleans Police Department, Louisiana, Police Officer, aged 24, with over two years law enforcement experience with agency was fatally wounded on 01/28/2008. At approximately 10 a.m., officer was conducting field interview of possible suspect in rape investigation. After failing to comply with officer's verbal commands, suspect attacked officer. Officer and subject continued to fight each other on ground for over five minutes. Subject took officer's ASP and struck victim officer in head seven times. Subject eventually obtained victim officer's .40 caliber service weapon, shooting victim 15 times in head and body. Subject remained on scene until responding officers arrived and took him into custody. Victim officer was transported to local hospital but was pronounced deceased upon arrival. Incident was captured on store surveillance video. Subject was charged with first degree murder.
